The explanation of My curious presence and circumstances in the Corpus Christi Community with information regarding relevant current events impacting the community. This is a legal notice from Senior Joint Chief General Mark A. Milley.

Sirs, firstly this notice is being written by a singular being, not a committee or organisation. I Am H. L.
