Re: Sexual slavery and abuse of Me as a minor, against My will and personal God construct, from February 14, 1975 to November 19, 1988 Midnight. You own Me \$500,000,000,000.00 in back wages as the flesh Spirit prostituted to power your profane existence, against the LORD, as Satan's true religion.

Legal Council,

This is My declaration of legal action against you. I Am, H. L. MacRae (mac) Dukes the future plaintiff. I Am also the Christ. I Am suing the Governing Body of Jehovah's Witnesses, et al with its Watchtower Bible and Tract Society of New York, Inc., future defendant-appellant. Thomas J. Henry of Texas has been copied this correspondence for his opportunity to represent Me in this legal matter. The extent of Spirit moving against Jehovah's Witnesses extends to all persons including those even looking in the direction of Jehovah's Witnesses with any expression, action, or intent less than contempt. The only phase that will identify a non-sympathiser, protecting the person from the stated abuse from Spirit, will be, "Fuck you" in refusal of Jehovah's Witness literature.

Mr. Henry's failure to represent My legal matter in a court of law demanding My \$500,000,000,000.00 wages on My behalf is an unfortunate blight against the legal community of the United States of America. This letter is his notification that Heaven is no longer powering law in the United States of America. Mr. Henry can correct this wrong by representing Me, and this case. He has until April 14, 2023 to contract with Me in this matter. Heaven closes its doors to law in the United States on the date stated, and under the circumstances stated, with his refusal.

You can begin your defence responding to My accusation under law, anticipating Mr. Henry's suit, by reading My *Herald* articles at herald.macdukes.com. You may also simply pay my back wages, \$500,000,000,000.00. In lieu of cash, you may quit claim to Me all assets and chattels employed by your religion the world over.
