Mr. De La Cerda,

I scheduled an appointment with you for February 2nd, Thursday at 1100. This letter replaces My typical introduction, and emphatically makes clear, Mark Elliot Gurgevich has not subsidised, bartered, nor paid for in cash or valuable consideration his lodging in My home at 4622 Dody Street Corpus Christi Texas 78411. My appointment is fulfilled with My delivery of this letter.

Mark has ultimately resided as a guest in My home. My understanding was his veteran benefits were based on service to the nation, and his low income. I trust you will protect the interest of Veterans Affairs for its continued longevity. Should I be eligible to receive a stipend for Mark's housing and care, please relate that to him. He has a number of persons in Corpus who could benefit from being his provider. He is free to make that choice.

This communication would not be complete without making clear to you who you are to the LORD.
